# **Family Services**


Family services are a vital component of the Head Start/Early Head Start (HS/EHS) program, ensuring families receive the support and resources needed to thrive.

Through Crystal Stairs' extensive network of services, families have access to a wide range of community resources, including employment support, resource and health fairs, and parent conferences and training workshops. Each family is assigned a Family Services Associate, who works closely with them to facilitate access to essential services in key areas, including health and wellness, social services, mental health support, parent engagement, nutrition, support for children with disabilities.

To assess the impact of our family services, CSI Head Start conducted a Family Outcomes Survey, measuring how families felt they benefited from the program. This survey evaluates our effectiveness across seven key outcome areas aligned with the Head Start Parent, Family, and Community Engagement (PFCE) Framework, ensuring that we continue to provide meaningful and impactful support to the families we serve.




% Families as Lifelong Educators



Parent Policy Council Participation




#### **Parent Testimonial**

# **Enrollment**

All families met the Head Start eligibility requirements, qualifying based on income or specific family circumstances, such as foster care placement, a diagnosed disability, or having a parent who is currently incarcerated.



# **School Readiness**

At CSI Head Start/Early Head Start, our curriculum is thoughtfully designed to foster growth and prepare children for kindergarten through engaging, hands-on learning experiences. By combining play-based learning, positive social interactions, and structured instruction, we create a dynamic and nurturing environment where young learners can thrive.

Aligned with California state standards for kindergarten, our curriculum ensures that every child receives a strong educational foundation. To effectively track progress and development, we utilize the Desired Results Developmental Profile (DRDP), conducting assessments at the beginning, middle, and end of the academic yea. Our assessment approach includes: portfolio evaluations, observations of learning and social interactions, and assessments in key developmental domains.

Using these insights, our educators tailor lesson plans to meet the unique needs of every child. Whether through individualized attention, small group activities, or whole-class instruction, we ensure that learning experiences are developmentally appropriate, engaging, and designed to foster a lifelong love of learning.

CSI Head Start's holistic approach to early childhood education ensures that children are not only academically prepared for kindergarten but also equipped with the social, emotional, and physical skills essential for success in both school and life. By fostering a well-rounded foundation, we empower young learners to thrive in all aspects of their development, setting them on a path toward lifelong learning and achievement.

# We've Got Class!

At CSI Head Start, we are committed to delivering high-quality early childhood education, and we use research-based tools to assess and enhance our programs continuously. One of our key assessment tools is the CLASS® (Classroom Assessment Scoring System) observation tool, which evaluates and improves the quality of teacher-child interactions in our classrooms.

**CLASS®** helps us: enhance instructional excellence by assessing teacher-child interactions; guide professional development for educators; inform programmatic decisions to strengthen learning experiences; ensure accountability in maintaining high educational standards; and contribute to early childhood education research.

In addition to CLASS®, we also utilize the Early Childhood Education Environmental Rating Scale (ECERS) to assess the quality of our learning environment. This tool provides a standardized measure, with a top score of 7, ensuring that our centers meet the highest standards of quality and care for our families.

Through these rigorous assessment methods, CSI Head Start continuously refines and enhances our programs, ensuring that every child receives the best possible start in their educational journey.

# **Health Services**

At Crystal Stairs Head Start/Early Head Start we prioritize the health and well-being of every child by integrating best health practices into daily learning experiences. Our goal is to ensure that each child receives the comprehensive health care they need to thrive.

To support children's overall wellness, we ensure they are up to date on well-child health care requirements, including age-appropriate immunizations, routine medical check-ups, and preventive screenings. Head Start mandates that all enrolled children visit a doctor annually for a well-child check-up and see a dentist every six months for preventive oral care.

By fostering strong partnerships with families and healthcare providers, Crystal Stairs Head Start/Early Head Start ensures that children receive the medical and dental care they need for a healthy start in life.

# **Child Care Partnerships**

For the past decade, Crystal Stairs, Inc. has proudly implemented the Head Start/Early Head Start Child Care Partnership program expanding access to high-quality comprehensive services for low-income working families. Through a strategic layering of funding, this initiative ensures children, birth to 48 months, receive full-day, full-year care while benefitting from a Head Start/Early Head Start education that prepares them for school success. Our licensed Child Care Partners (center-based and family child care home providers) share our commitment to supporting children and families and adhere to Head Start standards promoting program quality and ensuring effective, nurturing and responsive teaching practices to foster children's cognitive, social and emotional development.

Crystal Stair's Child Care Partnerships have markedly enhanced the quality of early learning environments, enriched child developmental services, and bolstered family support systems. By incorporating Head Start's comprehensive services into private childcare centers and family childcare settings, CSI has significantly improved outcomes for both children and their families.
